YOU ARE HEREBY NOTIFIED THAT IN ACCORDANCE WITH TAOS COUNTY ORDINANCE NO. 1996-8 BEING THE "ORDINANCE IMPOSING A BUSINESS REGISTRATION FEE", YOU ARE HEREBY REQUIRED TO FILE WITH THE COUNTY CLERK, AN APPLICATION FOR BUSINESS REGISTRATION, ON OR BEFORE AUGUST 31ST OF EACH YEAR.

AS PER TAOS COUNTY ORDINANCE NO. 1996-8 IN ADDITION TO OTHER REMEDIES PROVIDED BY LAW AND THOSE SET FORTH HEREIN, ANY PERSON WHO VIOLATES THE PROVISIONS OF THIS ACT, OR FAILS TO COMPLY WITH ANY OF ITS REQUIREMENTS, SHALL BE SUBJECT TO A LATE FEE OF TEN DOLLARS (\$10.00), LATE FEE SHALL BE DUE AND PAYABLE WITHOUT FURTHER DEMAND FROM THE COUNTY.

THIS FEE IS IMPOSED PURSUANT TO SECTION 3-28-3 NMSA, 1978 COMP. AS IT NOW EXISTS OR AMENDED AND SHALL BE KNOWN AS "THE BUSINESS REGISTRATION FEE."

ANY PERSON PROPOSING TO ENGAGE OR ENGAGING IN BUSINESS WITHIN TAOS COUNTY (OUTSIDE OF THE FOUR MUNICIPALITIES OF TAOS COUNTY), SHALL APPLY FOR AND PAY A BUSINESS REGISTRATION FEE FOR EACH OUTLET, OR LOCATION WITHIN THE LIMITS OF TAOS COUNTY PRIOR TO ENGAGING IN BUSINESS.

YOUR BUSINESS LICENSE IS VALID FOR ONE YEAR IF AT ANYTIME YOU CLOSE YOUR BUSINESS IT IS YOUR RESPONSIBILITY TO CONTACT OUR OFFICE TO LET US KNOW. IF YOU DO NOT AND YEARS LATER YOU WISH TO REOPEN YOUR BUSINESS YOU WILL BE SUBJECT TO A \$45.00 FEE FOR EVERY YEAR SINCE YOUR LAST LICENSE.
