APPOINTING MEMBERS TO THE TAOS COUNTY  
PLANNING COMMISSION FOR CALENDAR YEAR 2025

WHEREAS, the Taos County Board of County Commissioners is the duly authorized governing body of Taos County, a New Mexico political subdivision; and


WHEREAS, Section 4-57-1, NMSA 1978, provides for the creation of a Planning Commission consisting of at least 5 members by any county through the adoption of an ordinance; and

WHEREAS, the Taos County Board of County Commissioners approved Ordinance 2018-2 Land Use Regulations providing for the appointment of five (5) Planning Commission members who shall also serve as alternates to the Board of Adjustment. The term of the members will be for a term that ends on December 31<sup>st</sup> of each year. The Board of Commissioners will appoint or reappoint Planning Commission members in the month of January of each year, but no later than January 15th.

NOW THEREFORE BE IT RESOLVED, that the Taos County Board of County Commissioners appoints the attached list of persons to serve as the Taos County Planning Commission and as alternates to the Board of Adjustment. The appointees shall assume their duties effective at the recordation of this resolution and shall serve in such capacity for the term specified above. The attached list of appointees is hereby authorized and empowered to execute and to fulfill the duties of the appointed office according to the Constitution and Laws of the State of New Mexico, Planning Commission By-Laws and Taos County Ordinances.
