APPOINTING A TAOS COUNTY DWI PLANNING COUNCIL

WHEREAS, the Legislature of the State of New Mexico has provided for state and local programs and services for prevention related to DWI and Alcohol Abuse and enacted the Local DWI Grant Program Act (Chapter 65, Laws of 1993), §§ 11-6A-1 NMSA, *et seq.*, (“the Act”); and,

WHEREAS, the Act provides that grants shall only be accepted from Counties that have established a DWI Planning Council; and,

WHEREAS, the Commission has the authority to create, appoint, dissolve, remove and suspend committees, councils, boards and members to assist in the performance of its duties and responsibilities; and

WHEREAS, the Council shall consist of 11 voting members and 2 non-voting members appointed by the Taos County Board of Commissioners.

NOW, THEREFORE, BE IT RESOLVED by this Governing Body of the County of Taos, New Mexico, that at a duly convened regular meeting, approval was given to establish a DWI Planning Council, which will have the following duties:

- Provide non-binding recommendations to the Taos County Board of Commissioners and the Taos County DWI Coordinator for the use of said funds.

BE IT FURTHER RESOLVED that,


