WHEREAS, the Taos County Board of County Commissioners is the duly authorized governing body of Taos County, a New Mexico political subdivision; and


WHEREAS, Section 4-37-1, NMSA 1978, provides for the adoption of ordinances to further the health, safety and welfare of the citizens of Taos County; and


WHEREAS, the Taos County Board of County Commissioners approved Ordinance 2018-2 Land Use Regulations providing for the appointment of three (3) Board of Adjustment members who shall serve as alternates to the Planning Commission. The term of the members will be for a term that ends on December 31st of each year. The Board of Commissioners will appoint or reappoint Board of Adjustment members in the month of January of each year, but no later than January 15th.

NOW THEREFORE BE IT RESOLVED, that the Taos County Board of County Commissioners appoints the attached list of persons to serve as the Taos County Board of Adjustment and as alternates to the Planning Commission. The appointees shall assume their duties effective at the recordation of this resolution and shall serve in such capacity for the term specified above. The attached list of appointees is hereby authorized and empowered to execute and to fulfill the duties of the appointed office according to the Constitution and Laws of the State of New Mexico, Board of Adjustment By-Laws and Taos County Ordinances.


