
WHEREAS, this process contributes to local and regional efforts in project identification and selection in short- and long-range capital planning efforts.

NOW, THEREFORE, BE IT RESOLVED, by the Taos County Board of Commissioners that:


1. The Taos County has adopted the attached FY 2027-2031 Infrastructure Capital Improvement Plan.


