**AUTHORIZING SUBMISSION OF A LEASE OF THE TAOS COUNTY DETOX FACILITY TO RIO GRANDE ATP, INC. TO THE STATE BOARD OF FINANCE, TO ENABLE THE OPERATION AND PROVISION OF ADULT SUBSTANCE USE DISORDER DETOXIFICATION SERVICES IN NORTH CENTRAL NEW MEXICO**

**WHEREAS**, the Board of County Commissioners of Taos County, hereinafter the "Board ", is statutorily empowered to promote the public welfare of the residents of the County; and

**WHEREAS**, Taos County is the owner of the Property which includes real property, structures and improvements located at 1421 Weimer Road, Taos New Mexico in Taos County; and

**WHEREAS**, this property was acquired and improved by Taos County to establish an Adult Substance Use Disorder Detoxification Service Facility; and

**WHEREAS**, the Board wishes to lease the Property to Rio Grande ATP, Inc., to operate and provide urgently needed adult substance use disorder detoxification treatment servicing the North Central New Mexico region; and

**WHEREAS**, Rio Grande ATP, has provided behavioral health and substance abuse treatment in Northern New Mexico since 1978 and has been in the forefront to reopen a regional detox since the closure in 2015; and

**WHEREAS**, the Board understands that the lease template will not be valid until approved by the New Mexico State Board of Finance hereinafter "SBOF"; and

**WHEREAS**, the Board wishes to authorize the County Manager to initiate the final approval process of the lease with the SBOF in accordance with Section 13-6-2.1 NMSA 1978; and

**WHEREAS**, the Board further authorizes the County Manager to take any other action necessary to comply with any BOF requirements; and

**IT IS THEREFORE RESOLVED** by the Taos County Commission that:


1. The Board hereby authorizes the leasing of the subject property to Rio Grande ATP Inc.
2. The Board authorizes and directs the County Manager to initiate the final approval process for the lease of the Taos County Detox Facility and to take any other action necessary to comply with any SBOF requirements.

- The Board authorizes and directs the County Manager to execute such documents as may be reasonable and necessary to complete the application and approval process to lease the Property to Rio Grande ATP, Inc.
