AUTHORIZING, REQUESTING PARTICIPATION AND FUNDING IN THE NEW MEXICO DEPARTMENT OF TRANSPORTATION (NMDOT) FY 2025/2026 LOCAL GOVERNMENT ROAD FUND PROGRAM, CONTROL NO. HW2L500613 FUNDING COOPERATIVE AGREEMENT

WHEREAS, the Taos County Board of Commissioners (Board) is the duly authorized governing body of Taos County, a New Mexico political subdivision; and

WHEREAS, Taos County and the New Mexico Department of Transportation have entered into a joint and coordinated effort; and

WHEREAS, the total cost of the project will be \$109,188.00 to be funded in proportional share by the parties hereto as follows

- a) New Mexico Department of Transportation's share shall be 75% or \$81,891.00
- b) Taos County's proportional matching share shall be 25% or \$27,297.00; and

WHEREAS, Taos County shall pay all costs, which exceed the total amount of \$109,188.00.

NOW THEREFORE, BE IT RESOLVED by the governing body of the County of Taos, New Mexico, at a duly convened Regular Meeting held on September 2, 2025 that Taos County requests the amount of \$109,188.00 for LGRF Project Control No. HW2L500613 for FY 2025-2026 for **PLAN, DESIGN, RIGHT-OF-WAY ACQUISITION, PROBABLE COSTS, BLADING & SHAPING, CONSTRUCTION, RECONSTRUCTION, PAVEMENT REHABILITATION/IMPROVEMENTS, DRAINAGE IMPROVEMENTS, AND MISCELLANEOUS IMPROVEMENTS OF VARIOUS COUNTY ROADS.**
