**ESTABLISHING LEGAL HOLIDAYS,
OPERATING HOURS, AND CLOSINGS OF TAOS COUNTY OFFICES FOR
CALENDAR YEAR 2026**

WHEREAS, the Board of County Commissioners, of Taos County, New Mexico propose to allow Legal Holidays and Closing of County Offices for all Taos County Employees for the Year 2026.

NOW, THEREFORE, BE IT RESOLVED that the Taos County Board of Commissioners hereby authorizes the following dates as Legal Holidays closures for Calendar Year 2026;

NEW YEARS DAY - will be observed Thursday, January 1, 2026

MARTIN LUTHER KING, JR.'S BIRTHDAY – will be observed on Monday, January 19, 2026

SPRING DAY – will be observed on Friday, April 3, 2026

NEW YEARS EVE - will be observed Thursday, December 31, 2026 – Noon Dismissal





Taos County 2026 Employee Calendar


